Collective Impact Forum: <http://www.fsg.org/collective-impact-forum> is a resource for people and organizations using the collective impact approach to address large-scale social and environmental problems.

The *Nonprofit Quarterly* (NPQ, <https://nonprofitquarterly.org>) is an excellent independent nonprofit news organization that for more than 15 years has been serving nonprofit leaders, charitable foundations, educators, independent activists, and others involved in the civil sector. NPQ's guiding philosophy is that an active, engaged, and sometimes disruptive civil sector is critical to a healthy democracy in the same way that a free and independent press is. NPQ produces a quarterly magazine, online articles, webinars, and a daily newswire with the latest nonprofit-related stories relevant to practice. It produces articles on innovative thinking in governance, especially in relationship to governance beyond the structure of the board.

The *Nonprofits Integrating Community Engagement (NICE) Guide* (NICE, <http://www.buildingmovement.org/reports/entry/NICE>) is a joint project of the Alliance for Nonprofit Management and the Building Movement Project, the *NICE Guide* offers information, tools, case studies, and other resources to help nonprofit groups develop core competencies on constituent and community engagement. The *NICE Guide* is designed for organizational development experts, management support organizations, and internal and external consultants to facilitate efforts to integrate the voice of community members and constituents into the daily practice of nonprofit organizations.

The *Stanford Social Innovation Review* (https://ssir.org/articles/entry/collective_impact) produces a quarterly magazine and online articles, which includes articles on collective impact, webinars, blogs, podcasts, and conferences. It is published by the Stanford Center on Philanthropy and Civil Society at Stanford University. Its mission is to advance, educate, and inspire the field of social innovation by seeking out, cultivating, and disseminating the best in research- and practice-based knowledge.
